

4TH BANK WINDHOEK NAMIBIA NATIONAL JUNIOR CHESS CHAMPIONSHIPS 2011:

1. **VENUE:** Windhoek at the Dawid Bezuidenhout High School—School Hall, Paul van Harte Street, Khomasdal, Windhoek.
2. **EVENT DATE:** 9 July 2011
3. **REGISTRATION:** 29 June 2011 - 8 July 2011.

NB: The winner of the U/20 section will be the overall winner. Should a player wish to play in this open section they may do so. Any player of a younger age group may play in any other age groups above them. Players may not change once they have registered to play under a certain age group. The registration fees will remain as indicated above.

5. SYSTEM AND RATE OF PLAY:

The championship format will be a SWISS System tournament played over 7 (Seven Rounds) Rate of play will be 40 minutes for the entire game (20 minutes per player).

6. PAIRING AND TIE BREAK SYSTEM:

Swiss Perfect will be used for the pairings. Please note that the breaks between rounds will be used to do the pairings according to the **SWISS SYSTEM**. TIE-BREAK, Direct encounter, Progressive Score and Median Bucholz, will be applied. If players are still tied, then 1 game of Armageddon (5 minutes for black and 6 minutes for white) will be played.

7. NATIONAL CHESS RATINGS:

A chess player who does not have a national rating will receive a rating based on his/her performance against rated players.

8. WHO MAY PARTICIPATE?

All minors U/20 years of age according to FIDE Standards.

9. 4TH BANK WINDHOEK NAMIBIA NATIONAL JUNIOR CHESS CHAMPIONSHIP (Closed) 22,23,24 JULY 2011.

The 1st 6 (six) Namibian participants of all age groups in the final standings of this event will be invited to the closed championship from 22,23,24 July 2011. The winner of this event will be the Namibian Junior Chess Champion of Namibia and will be eligible to represent Namibia at International Junior Chess Events.

3. No assistance to chess players will be allowed during their games.
4. Touch is a move, unless the piece has no legal moves.
5. Any player who make themselves guilty of rude behavior will be disqualified with immediate effect.

The rapid rules of FIDE will apply during this event.
